Cluster Tour registration for the 15th TCI Annual Global Conference, 16 October 2012, Basque Country

Delegates will have the chance to explore some of the region's innovative clusters - renewable energy, machine tools, wine and tourism, aerospace, automotive, bioscience... - and unique experiences such as the city regeneration of Bilbao or the cooperative organisation of Mondragon. The first day of the 15th TCI Conference (16-19th October) will be devoted to visiting innovative clusters in high-growth, high-value areas where the Basque Country has particular expertise.

Position Paper "Integrating Cluster Policies within the future EU programmes"

Future research & Innovation policies should address the changing role of clusters to facilitate the emergence of new and revitalised competitive industries in EU, ensure stronger engagement of SMEs in EU programmes.

On the basis of its collective experience, the TACTICS consortium, together with members of the European Cluster Alliance (gathering 120 members, policy makers), with EU networks EURADA and ERRIN would like to emphasize the need for a strong cluster policy within the future EU programmes dealing with regional competitiveness.

Striving for excellence should thus be a high priority. Despite the importance of clusters, they seem to have been somewhat missing in the discussions about the future research & innovation policies. Not only are **clusters central to**

innovation & competitiveness, they also have adapted to new trends. Therefore, we must now make a **better use of clusters**. Clusters are a necessary, an important tool to improve economic performance.

Examples of smart clusters for a planned guide by the European Commission - Indian Cluster Initiative

The Indian government has declared 2010-2020 as the "Decade of Innovation". The cluster initiative aims to facilitate creation of ecosystems that will enable generation of new products, services, processes and business models, spurring job creation and inclusive growth. In both developed/developing countries,

MSMEs & start-ups are viewed as major engines of growth, employment. In 2010-11, Indian MSMEs represented 45% of manufactured output, 40% of exports. India is estimated to have 5,000 regional MSME clusters that include the gems cluster in Surat (Gujarat), brassware cluster in Moradabad (UP), textile cluster at Tirupur (Tamil Nadu).

Most MSME clusters in India suffer from lack of access to technology, research and development (R and D), financing and skills which in turn impact their growth and productivity. NInC aims to create models for transforming regional MSME clusters into innovation ecosystems with collaborative partnerships among stakeholders.

Cluster Innovation Centres (CICs) acting as networking hubs for innovation ecosystems are being created in 8 clusters. In many instances, interactions between industry, research and development (R and D), academia and others had happened for the first time within the cluster.

The NInC has partnered with Council of Scientific and Industrial Research (CSIR), Infrastructure Leasing and Financial Services Ltd (ILFS), Foundation of MSME Clusters (FMC), Tata Management Training Center (TMTTC) and industry lobbies CII and FICCI for the 6 months pilot phase of this initiative which started in November 2011.

Examples of smart clusters for a planned guide by the European Commission - a cluster in Lombardia, Italy

An Italian cluster, places in Region Lombardia, Northern Italy, has been recognized as a special innovative case because of its embedded innovation, resulting from a strongly integrated supply chain, a high export turnover rate (demand driven innovation), a thin but evident technological component such as industrial engineering, trend tendencies and packaging design. In 2005, a group of 40/50 companies in the Region, together with all the elements of quadruple helix, set up an Italian cosmetic cluster (Polo Cosmesi of Crema), with smart coo-petition and networking as keywords.

Now companies are more than 130. All of this partly came from a conversion of an abandoned industrial area from late '90s, so called reindustrialization. A big business site closure (Olivetti) and crisis in local mechanical enterprises in 80s and early '90s had destructive impact, but the involved stakeholders began together a process of renovation.

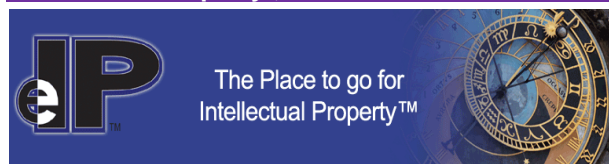

European Parliament gives final green light to energy efficiency directive

The EU tightened the energy efficiency thumbscrew by one notch yesterday (11 September), when the EU Parliament plenary threw its weight behind the new Energy Efficiency Directive, negotiated before the summer break with EU member states. EU aims to reduce its primary energy use by 20% by 2020, a target which is not legally binding. The EU Parliament & Council, together with the EC reached a deal on the proposed directive in June 2012. The directive:

- Proposes individual measures for each of the sectors that could play a role in reducing energy consumption - apart from transport, which is voluntary. This includes a controversial obligation on energy companies to achieve 1.5% energy savings per year on their customer's bills.
- Asks member states to develop long-term strategies for the energy-efficient refurbishment of EU's building stock.
- Obliges authorities to renovate public buildings, although this only applies to those "owned and occupied" by national governments, not regional or local authorities.

The directive came as a result of the March 2007 EU summit, when member states had struck an agreement on a 20% energy efficiency target by 2020, together with a 20% renewable energy target and a 20% CO2 reduction target. Whilst

the latter two were dealt with immediately, the energy efficiency law was postponed to 2012. Member states have agreed on an indicative target of 20% energy savings and to binding measures. This is expected to result in a reduced 15% total energy savings by 2020, well short of the 20% goal that member states had previously agreed on in principle in 2007. To make up for the shortfall, the 15% will be complemented by fuel efficiency regulation for cars and new standards for products such as boilers, which will be added to the [Ecodesign directive](#). This brings EU savings to 17%.
