## Greek business clusters together to find strength in numbers

The euronews strand "Business planet" has published a video on the Greek cluster Corallia, which specialises in microelectronics. Thanks to the cluster, one of the featured companies, Inaccess, which installs monitoring systems in solar energy farms, has doubled utrnover, quadrupled exports and increased its staff from 10 to 50.

The cluster was set up in 2008 by Corallia, a non-profit organisation which had received 40-million euros from the European Regional Development Fund.

Nellas told euronews: "Through the cluster, we have been given the opportunity to promote and to improve our control and monitoring solutions. We have been given the opportunity to participate in some support actions like patents, IPR (intellectual property rights) management, marketing, product management and things like that"

Prof Makios went on: "This is a wealth. This can unite with a cluster in France, a cluster in Germany, a cluster in Lithuania, and create a big cluster, a bigger cluster, a European cluster in micro electronics which can conquer the world"

Main challenges are seen in the fields of human resources, knowledge-intensive services, regional disparities, and knowledge-transfer.
- b. Regions with a strong focus on industrial employment tend to face the challenge of having to support the creation and growth of innovative companies on a broad basis, while at the same time they need to develop specific and unique strengths not necessarily in line with their traditional ones. Particularly, strengthening the role of clusters are the main specific challenges for this group of regions.
- c. The 'science & services regions' may be globally well positioned with a view to the capacities of their public R&D sector, they perform below their capacities with a view to translating these activities into industrial dynamics.

The major challenges are to enhance business R&D, to better exploit existing public research, to improve the linkages between public R&D & industry. Attention to innovation in services, which offers opportunities for growth and jobs.

#### The Global Competitiveness Report 2011-2012

The Global Competitiveness Report 2011–2012 comes out amid multiple challenges to the global economy. After a number of difficult years, a recovery from the economic crisis is tentatively emerging, although it has been very unequally distributed: much of the developing world is still seeing relatively strong growth, despite some risk of overheating, while most advanced economies continue to experience sluggish recovery, persistent unemployment, financial vulnerability, with no clear horizon for improvement. In addition, rising commodity prices are eroding the purchasing power of consumers, are likely to slow the pace of recovery. Such uncertainties are being exacerbated by growing concerns about the sustainability of public debt amidst the slow growth of some advanced economies.

This year's *Report* features a record number of 142 economies, and thus continues to be the most comprehensive assessment of its kind. It contains a detailed profile for each of the economies featured in the study as well as an extensive section of data tables with global rankings covering over 100 indicators.

Recent developments reinforce the observation that economic growth is unequally distributed and highlight the shift of balance of economic activity. On the one hand, emerging markets and developing economies, particularly in Asia, have seen relatively strong economic growth—estimated at 6.6 & 6.4 percent for 2011-2012, respectively, attracting increasing

financial flows. On the other hand, the United States, Japan, EU are experiencing slow, decelerating growth with persistent high unemployment and continued financial vulnerability, particularly in some EU economies.

GDP growth rates for advanced economies in 2011 are expected to remain at levels that, for most countries, are not strong enough to reduce the unemployment built up during the recession.
