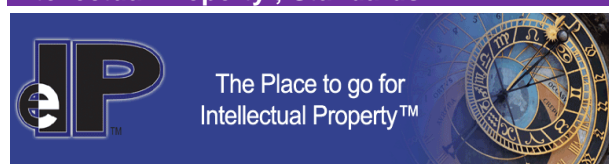

Study: Intellectual Property and Innovation

In the presence of European Commission Vice-President Neelie Kroes, the “Lisbon Council” launched **Intellectual Property and Innovation: A Framework for 21st Century Growth and Jobs**.

In this timely report, ten leading European intellectual property

thought leaders offer strategic advice on how to enhance the existing intellectual property regime for the digital age – and in turn boost innovation, encourage creativity and generate much-needed growth and jobs. Ian Hargreaves, professor of digital economy at Cardiff University and author of the high-level *Digital Opportunity* report prepared for UK Prime Minister David Cameron, contributed the Foreword.

The study was co-edited by Prof. Hargreaves and Paul Hofheinz, president of the “Lisbon Council”.

Research

Towards a more competitive and resilient European economy

The task of the European Commission's [Directorate-General for Research & Innovation](#) is to drive forward an integrated and world-class research and innovation system in Europe. Investing in research and innovation is a sure means to a more competitive and more resilient European economy.

The [EU2020](#) Strategy for growth & jobs gives research & innovation a prominent role. The main funding instrument to implement this policy has been the [Seventh Framework Programme for Research & Technological Development](#) (FP7).

Further progress was also made with regards to the [Innovation Union](#) flagship initiative. Thirty of the 34 Innovation Union commitments originally envisaged were already being addressed by activities launched before the end of 2011.

As part of the completion of the [European Research Area](#) (ERA), DG RTD boosted partnering initiatives/optimisation of the use and development of EU research infrastructures. New Public-Public Partnerships (P2Ps) were set up: 5 Joint Programming Initiatives (JPIs) and 12 European Research Area Networks (ERA-NETs).

DG RTD provided input on research & innovation aspects to general EC reports that reports included the [Annual Growth Survey](#) at the beginning, an assessment report at the end of the semester.

European Parliament gives final green light to energy efficiency directive

The EU tightened the energy efficiency thumbscrew by one notch yesterday (11 September), when the EU Parliament plenary threw its weight behind the new Energy Efficiency Directive, negotiated before the summer break with EU member states. EU aims to reduce its primary energy use by 20% by 2020, a target which is not legally binding. The EU Parliament & Council, together with the EC reached a deal on the proposed directive in June 2012. The directive:

- Proposes individual measures for each of the sectors that could play a role in reducing energy consumption - apart from transport, which is voluntary. This includes a controversial obligation on energy companies to achieve 1.5% energy savings per year on their customer's bills.
- Asks member states to develop long-term strategies for the energy-efficient refurbishment of EU's building stock.
- Obliges authorities to renovate public buildings, although this only applies to those "owned and occupied" by national governments, not regional or local authorities.

The directive came as a result of the March 2007 EU summit, when member states had struck an agreement on a 20% energy efficiency target by 2020, together with a 20% renewable energy target and a 20% CO2 reduction target. Whilst the latter two were dealt with immediately, the energy efficiency law was postponed to 2012. Member states have agreed on an indicative target of 20% energy savings and to binding measures. This is expected to result in a reduced 15% total energy savings by 2020, well short of the 20% goal that member states had previously agreed on in principle in 2007. To make up for the shortfall, the 15% will be complemented by fuel efficiency regulation for cars and new standards for products such as boilers, which will be added to the [Ecodesign directive](#). This brings EU savings to 17%.
