Cluster Analysis Report - Sustainable Organisation between Clusters of Optimised Logistics @ Europe

Five regional logistics hubs are cooperating to develop their clusters and collaborate. Together, they build a leading network of logistics gateways in Europe.

In order to achieve the project objectives, the clusters formulate a Joint Action Plan of specific joint projects and activities following a regional cluster analysis as the scope of the report. The study at hand has analyzed the participating clusters along selected, mostly publicly available statistics performance indicators, the quality of the regional business environment, the networking/cooperation structure, the specific context for innovation.

Nearly all logistics clusters in the project show an above EU-average economic performance in terms of the Gross Domestic Product, employment concentration in logistics, wages and salaries paid in the logistics sector. The clusters show a medium to high innovation performance in terms of patenting activity, scientific publications in logistics. The five regions represent essential areas of logistics (deep-sea hubs, airports, land-hubs, short-sea hubs), have different transport modes as the focus of their regional modal split.

The results from the analysis of the specific context for innovation show that the increase of market share, quality, range of products, services, processes are the most important drivers for logistics companies to innovate. The lack or uncertainties of customer demand along with the cost of innovation are the largest barriers for innovation. Suppliers, business clients, fairs, exhibitions, informal contacts are among the major sources of knowledge relevant for innovation. All clusters have identified a variety of joint needs for action, which they will translate into specific projects and activities within the subsequent definition of a Joint Action Plan.

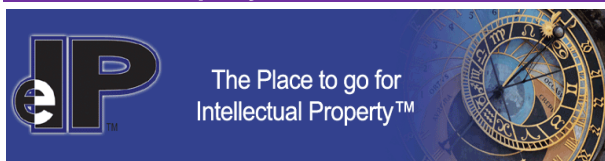

Why is it important to conduct a patent prior-art search?

Is my invention or idea patentable? This is usually an inventor's first question. It is very important to understand how to protect intellectual property in order to raise capital and create a definable market advantage.

There are certain preliminary patentability requirements regarding the nature of the invention that you can have us quickly assess through our special free initial consultation offer. In addition to being an acceptable type of invention, the invention must be novel with respect to relevant prior art. Fifth FP7 Monitoring Report

The Fifth FP7 Monitoring Report covers the implementation of the Framework Programme in the years 2007-2011. It is based on the FP7 Monitoring system, which was designed as an internal management tool using a core set of performance indicators. The FP7 Monitoring system is complementary to existing systems of data collecting and monitoring at operational level and within different DGs. While a substantial part of the report is based on existing material which has been already (at least partially) released, each annual Monitoring Report provides an integrated view on the different strands of FP7 activities.

FP7 builds on the achievements and good practice of earlier Framework Programmes with a good deal of continuity both at an operational level and in terms of strategic objectives. There are however, a number of novelties which represent a significant change compared to previous Framework Programmes.

Launched in 2010, the OpenAIRE portal operates an electronic infrastructure for handling peer-reviewed articles as well as other important forms of publications. Users can search and browse articles, while scientists are provided with post-authoring tools, as well as monitoring tools through analysis of document, usage statistics.

OpenAIRE's main objective is to support the implementation of 'Open Access' in EU. The EC programme grants free Internet access to research articles, with a view to accelerating scientific progress. CORDIS already compiles project details, participant contacts, links to official websites, related news. Via the OpenAIRE portal, it now links to existing final published articles and/or peer-reviewed manuscripts deposited into an institutional, subject-based or orphan repository.

Innovation and Entrepreneurship

Regional Innovation Scoreboard 2012

This edition of the European Regional Innovation Scoreboard (RIS) provides a comparative assessment of innovation performance across NUTS 1 / NUTS 2 regions of the EU, Croatia, Norway, Switzerland. As the regional level is important for economic development, for the design/implementation of innovation policies, it is important to have indicators to compare/benchmark innovation performance at regional level. Such evidence is vital to inform policy priorities, to monitor trends. The 2012 Regional Innovation Scoreboard replicates the methodology used at national level in the Innovation Union Scoreboard (IUS), using 12 of the 24 indicators used in the IUS for 190 regions across EU.

It is proven in the report that there is considerable diversity in regional innovation performances. The partner regions of the SoCool@EU project Rijn-Schelde Delta (NL/B), Frankfurt/Rhein-Main (DE), Øresund (SE/DK) are considered are Innovation Leaders, Aragón (ES) Innovation Follower. Delivering Europe 2020 requires more involvement of local & regional authorities & more financial investment

A report published by the Committee of the Regions has shown that whilst there is widespread awareness/support for EU 2020, there is an urgent need to commit more financial resources and to better engage local and regional authorities if its ambitious targets are to be met. This is a step to allow local/regional authorities to be directly involved in EU2020.

The results of the report, "[Third CoR Monitoring Report on EU 2020](#)", are based on a number of surveys carried out by the CoR and form part of the institution's efforts to measure the impact of EU 2020 at a local and regional level. EU 2020, the report stresses, is therefore failing to benefit from the potential that a coordinated approach between the different levels of governance could bring in delivering its objectives.

There is a market failure to address, access to finance for SMEs has dried up. SMEs are hostage to the necessary clean up of balance sheets of banks which caused the crisis through reckless lending in the property market. As we pour public money into bank rescues, we should be obliging them to finance innovation. Moreover there should be a big shift from subsidising agriculture to funding R&D which addresses real needs.
