Technology Profiles

Innovative cancer therapy identified need in the market

Tumors have a major socioeconomic impact having a severe prognosis. Conventional treatment consists of surgery, chemotherapy and/or radiotherapy. The most recent serious risk factor that affects the whole planet is the nuclear accident in Fukushima, Japan, but we must not forget the new technologies that promise wealth but may be associated with pollution accidents. The theoretical model developed by Research Beyond Limits Ltd (RBL) enables development of innovative treatment technologies in tumor therapy. RBL will conduct technical feasibility studies of proposed solution, associated industrial research. RBL will test the technology in laboratory animals (1st stage), cancer patients (2nd stage). RBL will protect intellectual and industrial property rights. The proposed technology is the use of innovative materials able to respond to laser stimulation depending on its wavelength. Consequently, this behavior can lead to useful applications:

1. Thermal degradation can release drugs at target.

2. Creating a magnetic dipole, that can be stimulated in magnetic field. Secondary can be used as contrast agent for nuclear resonance imaging modified by external laser stimulation with or without tumor vascular damage, depending on the type of stimulation. The objectives of the proposal:

1. Testing technical feasibility/associated industrial research using innovative materials as targeted drug delivery system.

2. Testing technical feasibility and associated industrial research using magnetic dipole of innovative materials vascular destruction of targeted tissue (cancer areas) in the magnetic field of modified MRI system.

Launched in 2010, the OpenAIRE portal operates an electronic infrastructure for handling peer-reviewed articles as well as other important forms of publications. Users can search and browse articles, while scientists are provided with post-authoring tools, as well as monitoring tools through analysis of document, usage statistics.

OpenAIRE's main objective is to support the implementation of 'Open Access' in EU. The EC programme grants free Internet access to research articles, with a view to accelerating scientific progress. CORDIS already compiles project details, participant contacts, links to official websites, related news. Via the OpenAIRE portal, it now links to existing final published articles and/or peer-reviewed manuscripts deposited into an institutional, subject-based or orphan repository.

Small Business Act - SBA fact Sheet 2012

The European Commission released the results of the SME Performance Review, which includes the Annual Report on European SMEs and the country fact sheets describing SMEs' progress in all EU Members States. Despite the challenging environment, in 2012 SMEs stood their ground as the backbone of the EU economy, continued to strive for recovery. I advice to have a look to the points 3 & 4 as they look at technology enterprises/tech start ups.

The country fact-sheets assess progress in implementation of the SBA at national level, based on a set of indicators, national policy developments grouped according to the SBA's 10 policy dimensions. The SBA fact-sheets cover the 27 EU Member States, Albania, Croatia, FYROM, Iceland, Israel, Liechtenstein, Norway, Montenegro, Serbia, Turkey. Why strategies fail during their implementation phase ?

The more time passes, that the best-intentioned strategies, best made on paper are not being implemented successfully because they have to face difficulties in deployment of technological, human, financial resources as well as in targeting the market to be covered, whether in the public or the private sector. In the public sector, the main reasons of this difference between intentions and achievements are:

- public service offer not in line with demand;
 - evaluation based on transactions (number of beneficiaries) and not on transforming the ecosystem;
 - organisation-centric called JIMA (Just In My Administration);
 - failure in knowledge management;
 - dogmatic approach of politicians aiming at standardizing practices (cf. overdose of clusters/incubators, for instance);
 - short-term vision coupled together with multiannual programmes;
 - excessive use of grants;
 - capturing financial volumes (ERDF volume, Horizon 2020, etc) regardless their real purpose and the absorption capacity.
- How can certain representatives of Member States claim for a greater share of FP7 when their administrations are not able to absorb the funds they are allocated under the Cohesion Policy?

A Framework for European Crowdfunding

This paper give a concise overview of the state of crowdfunding in EU, with the aim of establishing policy and a distinct framework for the EU crowdfunding industry, efforts which we believe will aid in the economic recovery of EU.

Research shows the majority of job creation comes from small and medium sized businesses, which account for 99% of all businesses in EU. The vast majority of these have ten or fewer employees. These are also the businesses that have been most impacted by the economic crisis, need better access to capital in order to do what they do best: innovate, create jobs, restore stability. One of the most promising solutions for restoring capital to entrepreneurs and SME is crowdfunding, defined as the collective effort of individuals who network and pool their resources, usually via the Internet, to support efforts initiated by other people or organizations.

Crowdfunding allows entrepreneurs and SME to solicit capital from funders, using social networks and crowdfunding platforms to finance their businesses and projects. There is currently no established policy in EU for crowdfunding and we believe it is of the utmost importance to create crowdfunding legislation to remain competitive in a global market.
