# Clusters

## Presentation of the book "Logistics Clusters - Delivering value and driving growth"

Why is Memphis home to hundreds of motor carrier terminals and distribution centers? Why does the tiny island-nation of Singapore handle a fifth of the world's maritime containers and half the world's annual supply of crude oil? Which jobs can replace lost manufacturing jobs in advanced economies? Some of the answers to these questions are rooted in the phenomenon of logistics clusters—geographically concentrated sets of logistics related business activities. In this book, supply chain management expert Yossi Sheffi explains why Memphis, Singapore, Chicago, Rotterdam, Los Angeles, and scores of other locations have been successful in developing such clusters while others have not.

Sheffi outlines the characteristic "positive feedback loop" of logistics clusters development and what differentiates them from other industrial clusters; how logistics clusters "add value" by generating other industrial activities; why firms should locate their distribution and value-added activities in logistics clusters; and the proper role of government support, in the form of investment, regulation, and trade policy.

Sheffi also argues for the most important advantage offered by logistics clusters in today's recession-plagued economy: jobs, many of them open to low-skilled workers, that are concentrated locally and not "offshorable." These logistics clusters offer what is rare in today's economy: authentic success stories. For this reason, numerous regional and central governments as well as scores of real estate developers are investing in the development of such clusters.

## How the innovative company can be measured?

What are the key features that define innovative firm from lets say non innovative? The key message is to know how to balance access to, and the influence of, the 4 innovation leadership behaviours. If you have one missing, you will fail.

A business measure that has always appealed is "percentage of total sales produced by products that are less than X years old". It is simple, easy for everyone to understand, can be sued as a goal, connects the abstract concept of innovation to the concrete numbers of sales.

You can set the percentage, the number of years to be what you like, even have a multiyear plan to make them more challenging over time, but it seems such a measure (which comes from P&G) strips away all the obfuscation/demands that a company demonstrates the relationship between its professed innovation activities and its real results.

The clip focuses on the 3<sup>rd</sup> dimension of the Human Rights system, the collective rights. Those include -for example- the right to peace & to development.
