Ten new projects labelled in 2012 by EUREKA telecoms cluster Celtic-Plus

Fourteen proposals were submitted during the two calls for projects launched by the **EUREKA** telecoms cluster **CELTIC-Plus** in 2012. After the review of the proposals by a panel of experts, ten projects with a total budget of 106 million euros received the Celtic-Plus label. The labelled projects represent a total effort of 1030 men/year, contributing actively to employment in Europe but also beyond, as out of the eighteen countries involved in the CELTIC-Plus projects labelled in 2012, three are extra-European: Israel, South Korea and Turkey. The projects cover a wide range of new technological developments at a pre-competitive stage, including new standards, formats and technologies in Wi-Fi, 4G, mobile broadband, digital content distribution and streaming, and a promising video compression format called HEVC.

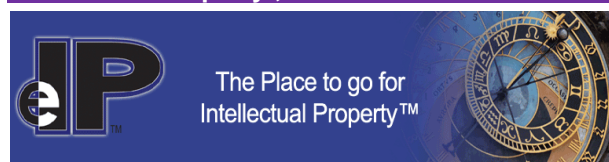

Horizon 2020 is the financial instrument implementing the Innovation Union, a Europe 2020 flagship initiative aimed at securing Europe's global competitiveness. Running from 2014 to 2020 with an €80 billion budget, the EU's new programme for research and innovation is part of the drive to create new growth and jobs in Europe.

Horizon 2020 provides major simplification through a single set of rules. It will combine all research and innovation funding currently provided through the [Framework Programmes for Research and Technical Development](#), the innovation related activities of the Competitiveness & Innovation Framework Programme (CIP) and the European Institute of Innovation and Technology (EIT).

Tracking exposure to environmental pollutants

Working to improve air quality is one of the areas in which the EU has been most active by controlling emissions of harmful substances, improving fuel quality, integrating environmental protection requirements into the transport, energy sectors. EU is funding its biggest investment in environmental health in a unique venture. Subjects will carry smartphones equipped with sensors to measure exposures to the environment, blood will be analysed to monitor molecular changes.

One of the goals is to look for biomarker differences between people walking through areas with low air pollution, those exposed to urban fumes, in order to understand the triggers for conditions such as heart disease, lung cancer, asthma.

The Top 10 Smartest European Cities

Which city in Europe is working the hardest to be the most advanced urban landscape? This year, I sought to more accurately rank cities based on a holistic model of smart cities around the globe. We are going to release two separate rankings. The 1st ranking represents the top 10 smart cities in EU, the 2nd, top 10 smart cities in North America.

In an attempt to improve the rankings, I developed a metric called the [Smart Cities Wheel](#), which contains six key components of smart cities and three key drivers for each component. For each of the six components of the Smart Cities Wheel, I sought to obtain more than one data source to rank each city in its respective region, except in cases where the singular data source was sufficiently rigorous (e.g. Mercer's Quality of Life rankings). As you might expect, not every city had data available from every source, so the more data points, the better.

5 lessons for core-funded & subsidized organisations

When I work with publicly funded organisations (university, research or non-profit), I try to avoid the word "business". For example, when I talk about a funding model I mean a business model. Most publicly funded organisations still think they are not a business. Nevertheless, they have to earn money to survive and pay checks. Certainly, if they receive a core funding, they do not have to worry a lot about the business and commercial side of their work. Life is good with core funding and substantial support from state.

However, the game changes with budget cuts. The moral of the organisation goes down. Best people start to leave the sinking ship. The managers are running after government officials, try to convince them to keep the support level.

Here are 5 lesson that might be useful for managers of core-funded organisations:

- 1) Use good times to develop a sustainable business and demand-oriented culture
- 2) Stay on the top of policy changes
- 3) Show your value and impact to stakeholders
- 4) Be ready to size-down
- 5) Keep the morale high by putting a new vision

Why is Innovation so important?

Innovation is important because it is the lifeblood of any business; without it a company will cease to exist. Additionally, innovation offers greater rewards for those that invest in it than those that invest in continuous/incremental improvements. Process of invention / innovation is distinct in three levels of research, fundamental research, technological research, technological progress redesign!

Fundamental research is based on scientific development of theoretical study and the need to bring data and evidence! Technological research is essential in depth knowledge of the technology in use, defining element of novelty / innovation / invention and the need / opportunity to apply change! If, fundamental research novelty is easily introduced and accepted by the academic environment technological research result is very difficult to introduce as new! During the redesign of consumer products, markets, consumers and producers waiting for funding newness is so easy lived as a researcher!

Unfortunately in technological research and effort to in-depth knowledge of existing technology and bringing innovation is extremely complicat. Busines environment is more open to stealing technology than research funding or acquisition of patents! Companies have many reasons to acquire patents: Develop platform innovation technology, Develop disruptive technology, Expand existing technology, Develop blocking technology.

Some companies spend a lot of time and money, they do research grant. Some are less and less is spent but requires innovation and creativity non the less and should never be belittle as younger less gray haired engineers read this. Other invention are strategic are important to companies and just because people don't understand and agree with the law and don't protected their ideas properly well they need to learn from their mistakes. As we learn for our failed experiments.

Companies have always had a flow of innovation, a flow sufficient for the needs of the company at that time. What I think has happened is that the flow from "before" is no longer sufficient to address the business challenges of today. Hence its importance has increased as has the pressure to get more and better innovation. At some point, the processes for innovation will catch up to the business need and then there will be something else that needs special attention. By then the flow of innovation will have reached a new level, a level that can address the business challenges.

Sure a company can and should improve its products based on customer feedback and continuous improvement; however, when it becomes dependent on, or gets trapped in the vicious cycle of continuous improvement to improve their bottom line, they too will be eliminated once an innovative product replacement becomes available.

All companies are interested in research that improves profits and invests in development. What is not shown in your explanation is corporate investment in reducing pollution, waste and reducing energy consumption, use of renewable energy, Research includes not only change, but redrawing a product and technology research. Researchers are upset because a company continues to heavily pollute the environment, wasting energy and not invest in research
