Clusters

Celtic-Plus – Smart Connected World – an EUREKA Cluster

Celtic-Plus intends to liaise with related initiatives in order to address global solutions. Other EUREKA clusters in energy, water technologies, manufacturing industry, but also the other ICT clusters, are the first candidates.

Get connected - addresses everything needed to establish, run and secure the communication, basically, the infrastructure, connectivity aspects. Key topics will be related to network elements, infrastructures. This includes wireless, optics and energy efficiency, as well as network architecture and connectivity, like networking and autonomic networks.

While connected - tackles all aspects while a communication is running, including, all requirements for new end-to-end services, applications. Celtic-Plus projects will deal with future end-to-end services, like digital home, digital enterprise, digital city, digital school, digital transport, and e-health, as well as horizontal services, like security, public safety and identity. The latter is particularly relevant for protecting the privacy rights of European users.

Celtic-Plus and the Future Internet - Celtic-Plus projects will also focus on the architecture and challenges of the Future Internet. One major challenge is to further develop the network infrastructure, which makes mobile Internet with high Quality of Service happen in conjunction with a much higher flexibility, capacity, mobility, so that future applications do not suffer from the current limitations of the Internet.

One important aim is the establishment of a “**Celtic-Plus Use-case Factory**”. The “factory” shall be complementary to the Future Internet PPP Calls under the FP7. As there will be more excellent Future Internet use case projects to be expected than can be funded under FP7 Celtic-Plus offers opportunity to realise some additional. Another focus may also be on capacity building, test cases/ platforms or alternative foundation platform.

Celtic-Plus & Green Internet - Celtic-Plus intends to be a driving force in EU & beyond for future greener telecommunications. Three major challenges are addressed: make environmental issues, encourage better energy efficiency, develop multidisciplinary solutions.

Celtic-Plus Calls for Proposals 2013

Celtic-Plus calls for proposals are defined on an annual basis. Every year there will be two submission possibilities for fully defined project proposals. **Submission deadlines (revised)** ([see also detailed call calendar](#)):

- Spring Call (2013-1): 23 April 2013 ([submission](#) is now open)
- Autumn Call (2013-2): 14 October 2013

The new fast call process will now only consider one single, full proposal phase; no Proposal Outline (PO) phase is required any longer. One important aspect to speed up the call and funding decision process is that each project participant must submit a national funding application in parallel to the proposal submission.

Without such national applications no label will be assigned. As compensation to the missing proposal outline phase Celtic offers the opportunity to submit a short proposal abstract (including a short project outline, intended consortium partners/countries) for a 1st check to the [Celtic Office](#). Well evaluated but not labeled proposals may get a 2nd chance by submitting refined proposals at the 2nd call deadline about six months later.

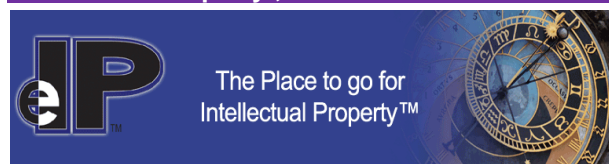

PCT at the EPO - Conference for patent professionals and industry, 13 June 2013, Munich, Germany

The participants may choose four from eight sessions run by experts from the EPO, from other major patent offices (USPTO, JPO, SIPO) and by experienced patent attorneys on:

- PCT filing, search and examination and entry into the European regional phase
- the national phases at SIPO/USPTO/JPO
- restoration and incorporation procedures under the PCT

The sessions will be followed by a panel discussion on key developments in the PCT, in particular the enhancement of PCT search, the strengthening of Chapter II and the simplification of entry into the national phase.

New Decision on legal and financial rules for the validation of FP7 participants

A new Commission Decision on the legal and financial rules for the validation of FP7 participants (LFV rules) has entered into force, which replaces the existing rules. While the update does not impose major modifications it introduces, however, several clarifications that reflect the current practice of the validation services. The main updates concern in particular the following issues:

- Definitions of legal statuses and categories
- Provisions regarding requested documents and the effective date
- Cases of incomplete, contradictory or false declarations and/or supporting documents
- Provisions regarding the Legal Entity Appointed Representative (LEAR)
- The procedures for modification and review of validations
- Provisions regarding the validation panel
- Specific cases within the verification of the financial capacity procedure concerning requested data and documents
- Definition of exceptional cases concerning the viability ratios
- Modification of the section on 'protection measures'

Innovation and Entrepreneurship

Don't Confuse Creativity With Innovation

Not so long ago that creativity was an important part of any innovation discussion. You could not separate the 2 terms. Guess what? Today, the terms are separated, the reason is that innovation is no longer viewed as a creativity effort. It has become a management discipline, as such this is more about strategy, structure, processes, culture than creativity. Innovation is the process of matching technology with market needs. Creativity is a part of that process, but it is not the same thing as innovation. You can be very creative in developing a new product or service, but that does not mean it will be successful or "innovative" if it does not meet a customer need and a customer is willing to buy it!

Innovation starts with creativity (and creative thinking) -- it creates sustainable value -- be it something new, something improved, something borrowed, something rediscovered, something adapted, or something reinvented. Some level of process, discipline can be helpful, the most successful companies avoid locking into ridged processes and methodologies -- preferring agile, responsive approaches and flexible, adaptive frameworks. They cultivate a culture of experimentation and play. They place equal value on customers and employees. They recognize that sustained growth requires a balanced portfolio of growth strategies and the management capabilities to implement them. The companies that "survive & thrive" adapt, evolve, explore, improve everyday.

It's the little things that mean a lot creativity is only ONE of the sources of successful innovation management, which include. copying others/doing it better. From Pampers to McDonald, Kodak or Microsoft (even Apple & Google), the successful innovators (i.e. the ones who created some business values) where NOT necessarily the ones who "invented". Creativity is thinking about new things. Innovation is doing new things. Managing innovation is doing new things that create value better than others... Creativity (like R&D) can in some cases play an important part of the innovation process, but in many organizations it is not a key issues (and is not the starting point).

Effective innovation requires a 'system' covering hard-edged stuff like process and budgeting together with 'soft stuff' like a supportive climate/culture and leadership. Too little focus on the 'soft' requirements will stifle innovative behaviours, too little focus on the 'hard-edged' stuff will create inefficiency - with poor ideas pursued by senior champions and better ideas not getting through. Creativity is but one part of the innovation journey.

We should also remember that 'individual' innovation is not the same as 'institutional' innovation. Many individual innovations are not scalable or even valuable to an organisation as a whole. Creating institutional-level innovation requires collection, aggregation and development, selection and exploitation of the best ideas from individuals and teams to bring new value propositions for the organisation as a whole.

innovation is implementing ideas to create value. Creativity is required to get better ideas, to solve challenges during implementation and to shape a good business model.

Creativity is the core element of innovation. But creativity alone will not make innovation happen. Many good ideas never become reality. Creative ideas need to be integrated into existing knowledge and used to develop new perspectives. Those perspectives then become the fuel for innovation. Throw in the will to make the idea work, some strategic planning, a good prototype and continuous improvement, and eventually, new ideas become reality.

Creativity is about thinking in new boxes... Innovation management is about people, teams identifying/selecting/ implementing new opportunities, in line with their objectives (a means, not an end).
