## Horizon 2020 - the programme that will cover all research & innovation funding 2014-2020, Budget: 71 billion

Horizon 2020 will be an integrated programme that will cover all research and innovation funding currently provided through the Framework Programme for Research and Technological Development, the Competitiveness and Innovation Framework Programme (CIP) and the European Institute of Innovation and Technology (EIT). The different types of funding provided by the existing programmes will be brought together into a single coherent, flexible framework. It will provide funding for every stage of the innovation process from basic research to market uptake.

Horizon 2020 is the financial instrument implementing the Innovation Union.

EU funding for R&I are focused on 3 key objectives (Excellent science, Competitive industries, Better Society). The aim of Horizon 2020 is to strengthen the EU's position as a world leader in science, to help make EU a more attractive location to invest in research & innovation, to bring excellent research results to market which will deliver direct benefits to citizens, affordable health-care, protection against cyber crime, the transition to a resource-efficient, low-carbon economy.

## Best practice - the developed laser technology can detect less than 1 mg of explosives at a 20-metre distance

The OPTIX consortium, supported by almost €2.5 million in EU funds for research, has successfully developed/tested a portable technology for the stand-off detection of explosives at distances of less than 20 metres. The new technology capable of scanning the molecular structure of explosive artefacts attached to vehicles, pieces of luggage, containers, is being tested by the Spanish Police Corps. Lab experiments, real-scenario simulations are currently ongoing. The new technology is expected to provide police/security forces with an asset in the fight against bomb attacks in the future.

Policy changes in some key countries, such as the moratorium on the wind industry in Spain and the last minute extension of Production Tax Credit in the US, will affect wind installations. Hence, it is estimated that there will be a slowdown in wind installations in 2013 compared with 2012's annual installations. Global wind industry growth will be driven mainly by China, the US, Germany, the UK and India.
