Just like an automobile, a business is a complex system with many factors to be monitored. Sales volume, past-due accounts, cash-flow, employee turnover, new customer acquisition, inventory turns, margins, balky vendors, quality measurements are just a few of the endless number of systems vital to the health of a company.

It is difficult, if not impossible to watch all these systems constantly so I advise business owners to create a few, vital measurements to scan daily in the same manner we scan our cars' dashboard, then delegate a second set of items that others monitor. When things go outside normal levels they are instructed to inform you in the same way the computers in your car turn on that "check engine" light.

#### **Innovation Metrics**

In organizations of all types there will always be a need for measurements. It's obvious organizations require information, data for calculations, assessments, evaluations, valuations, computations, etc., to make informative decisions in running, managing the organization. A business metric by definition is any type of measurement-usually a combination of measurements used to gauge quantifiable component of an organization's performance, such as ROI & EBITDA, etc.

There is a lot of discussion and some debate on the subject of innovation metrics for organizations, what are they and how should they be measured. I find this discussion a little amusing and somewhat ironic that we are debating innovation metrics and we can still not agree on "what is innovation" by definition within an organization.
