Science and technology statistics at regional level

You can find statistical information that illustrates regional developments for science & technology indicators within the EU. The domains covered are R & D, the number of researchers, human resources in science & technology (HRST), employment in high technology sectors, patent applications.

The EU-27 had an <u>R & D intensity</u> of 2.03 % in 2011, in other words, <u>expenditure on R & D</u> was equivalent to 2.03 % of gross domestic product (<u>GDP</u>). In the period between 2001 and 2007 there was little change in the EU-27's R &D intensity, as the level of expenditure in relation to GDP lay within a relatively restricted range from a low of 1.82 % to a

high of 1.88 %. There followed successive increases, as R & D intensity rose from 1.85 % in 2007 to 1.92 % in 2008 and by a further 0.1 percentage points in 2009 (to reach 2.02 %). Thereafter, there was another period of relatively stability as the EU-27's R & D intensity was 2.01 % in 2010 and 2.03 % in 2011.
