# 10<sup>th</sup> Progress Report on SMEs participation in the 7<sup>th</sup> R&D Framework Programme

The previous issue of this report, published in October 2012, highlighted that 16.3% of the total Cooperation Programme used budget went to SMEs. This figure further progressed to 16.9% over the past 9 months.

The main part of Cooperation Programme consists of the 10 Thematic Priorities. By the end of June 2013, SMEs made up 19.1% of all participations in the Cooperation programme. 74.6% of all the grant agreements in the thematic priorities involve at least one SME and 11% of all the project consortia are led by an SME coordinator. On the basis of the latest figures, the average EU contribution going to SMEs participating in thematic research projects is at € 284,000 per project. The total number of participations registered under FP7, including Research for the Benefit of SMEs & the Marie-Curie Actions, is close to 106,000 now, and includes 19,300 SME participations, receiving an average EU contribution of € 253,000. The SME participations represent 11,260 unique SMEs, while 24,800 unique organisations have participated in FP7 so far. This means that about 45% of the organisations participating in FP7 are SMEs.

The EC has published its Staff Working Paper "Strategy for EU Technology Platforms: ETP 2020". The strategy highlights the main tasks, activities of the EU Technology Platforms ETPs until 2020. It also presents the revised criteria for the recognition of ETPs by the EC, lists the recognised ETPs. ETP are industry-lead fora of private and public stakeholders which develop Research and Innovation Agendas and Roadmaps for a specific sector. In the Commission's proposal for Horizon 2020. ETPs are foreseen as advisors for the implementation of the Framework Programme.

According to the strategy, the main functions of ETPs will be: - development of strategies, - mobilisation of stakeholders, dissemination of knowledge and information sharing

#### **Global Innovation Index 2013**

Cornell University, INSEAD and the World Intellectual Property Organization (WIPO, a specialized agency of the United Nations) co-publish The Global Innovation Index (GII), now in its sixth edition. The GII recognizes the key role of innovation as a driver of economic growth and prosperity and acknowledges the need for a broad horizontal vision of innovation that is applicable to both developed and emerging economies, with the inclusion of indicators that go beyond the traditional measures of innovation (such as the level of research and development in a given country).

The GII has evolved into a valuable benchmarking tool to facilitate public-private dialogue, whereby policymakers, business leaders and other stakeholders can evaluate progress on a continual basis.

- agree a common vision for the future of their territory.
- agree on the means to be contributed by each partner in order to reach the objectives defined together.

Governance is a far more complicated process than the pursuit of so-called democratic legitimacy or the decentralisation of the responsibility for economic development. Innovative actions RIS-RITTS & RISI and the local/regional pacts that were promoted and funded from the EU's Structural Funds have made it possible to experiment with, proved the relevance of, a form of governance that applies to the adoption of structural regional strategies.

The objective of the project focuses on monitoring of water/underwater relevant parameters and data of the ecosystem state on the Black Sea's coastal protected areas. The project will involve the use of the AUV (autonomous underwater vehicle), underwater intelligent (multi-) sensors, underwater navigation, satellite positioning, remote sensing, satellite Earth observation, to create new knowledge/developments designs and build an experimental model for the new mobile hydro-acoustic laboratory.
