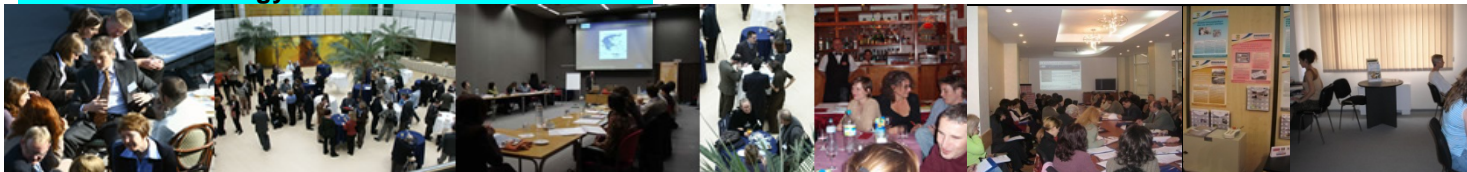

The Agreement on the **Unified Patent Court** was signed by 25 EU Member States, with the aim of **creating a specialised patent court with exclusive jurisdiction for litigation relating to EU patents** - a bundle of national patents with no single jurisdiction for disputes -

and EU patents with unitary effect, a legal title ensuring uniform protection for an invention across 25 Member States on a one-stop shop basis, providing huge cost advantages, reducing burdens.
