The 1st commitment period (2008-2012) of the Kyoto Protocol has ended without a global agreement to replace or extend it. The 2nd commitment period (2013-2020) has been established among part of Annex I countries and the set under CDM of the CCS mechanisms can not be considered as a significant step to confront the global challenge.

What is important is that now all countries developed and developing, understand that they have to contribute in the common effort. The global recession, the economic crisis in EU and USA has underlined the fact that developed countries of Annex I can not any longer be the only contributors to the efforts for mitigation of GHG emissions.

Countries of the Gulf and not only have experienced a remarkable increase of their wealth and further to that came to a point to understand that lowering their emissions could be beneficiary for their economies.

In this framework the development of New Market Mechanisms and their decentralized governance provides a broader basis for the development of "tailor made" green pathways of development.

Discussions and deliberations among groups of countries or even among districts and counties of big countries like China and USA are expected to converge with other on going negotiations aiming to conclude with a Global Emissions Trading around 2030. Countries of BSEC should not lose their window — opportunity to participate actively and most benefited from emerging opportunities of this green economy perspective.

Established in 1902, Università Bocconi is a research university of international standing in business, economics, and law. In addition to conducting research projects, the Center also manages thematic Observatories (Forum on European Energy and Environmental Policies, Observatory on Integrated Environmental Management Systems, Observatory on Communication and Environmental Information), open both to members and non-members, which focus on topics and issues of particular policy interest. These Observatories are high-level working platforms, where researchers, firms and institutions meet to discuss and compare different views and methods of analysis.

Prof. Edoardo CROCI is the Research Director of IEFE, where he teaches "Carbon Markets and carbon management". Also Professor of Institutions of Economics at the Milan State University and project leader of the "Green Economy Area" of CRIET interuniversity center for Economics of Territory. His main research areas are: economics of climate change, environmental policy, urban sustainability. Served as Milan City Deputy Major for Mobility, Transport and Environment, President of the Agency for the Protection of the Environment of Lombardy Region, Vice president of FEDARENE (European Federation of Regional Energy and Environment Agency), and Vice president of Italian Agenda 21 Coordination association. Member of the Editing Committee of the review "Economics and Policy of Energy and the Environment" and of the Scientific committee of the review "Management of utilities".

International Training Seminar on "Climate Change policies" (Trends, Modeling-LEAP, Evaluation-AMS)

Brief description

The International Training Seminar on Climate Change policies is a one-week training activity aiming to offer a holistic approach to the problems which policy makers from countries with emerging economies face in fulfilling their needs for such policies. Trainees will get updated on international policy trends, data collection, scenarios development, selection of policy mixtures with the use of LEAP (and

its updated versions) and their assessment with the use of AMS (for climate change policy mixtures). LEAP is a software tool for energy policy analysis and climate change mitigation assessment developed in SEI's (Stockholm Environment Institute) U.S. center. It is a widely-used tool in the world today with over two thousand users in more than 190 countries for energy and environment policy analysis. LEAP has been adopted as the tool of choice by numerous countries wishing to plan their energy systems to meet sustainable development goals. The AMS method is a multi-criteria method for evaluating climate change policy instruments or policy mixtures. with suitable modification for evaluating their interactions as well, developed in KEPA - NKUA (Energy Policy and Development Centre - National and Kapodistrian University of Athens). Both LEAP and AMS have been used for the development and assessment of M/A policy portfolios for twelve (12) countries of BSEC and Central Asia.

Organised by KEPA (Energy Policy and Development Centre of National and Kapodistrian University of Athens) in cooperation with the US center of Stockholm Environment Institute in Massachusetts and developer of LEAP (Long-range Energy Alternatives Planning system), the training seminar is addressed mainly to policy and decision makers (employees of ministries and agencies, consultants), economists, engineers, managers, researchers on energy and climate change policy as well as to researchers from Europe and Asia (Mediterranean, Black Sea and Central Asia region) and will take place in the premises of KEPA on the second week of November 2013. Participants from other areas are also welcomed.

Training format

Depending on the technical needs of each subject, presentations offering general background knowledge, familiarization exercises, interactive presentations, exercises on national case-studies as well as discussion on country experiences will be used, in order to increase the knowledge of each participant. The participants will work on the relevant exercises either on their own or in groups, choosing a certain country example. Suggested literature and notes will be provided, for further reading after the Seminar and more detailed information for each subject. Certificates of attendance/completion will be provided to the Farewell dinner on the last day of the seminar.

Expected outcomes

Participants will gain understanding and hands-on experience on the following:

- How to create a Mitigation/Adaptation Climate Change Policy mixture /portfolio
- How to compose a scenario and create a dataset
- How to use the LEAP software to run scenarios for different policy mixtures
- How to use the AMS method for the evaluation of policy mixtures
- How to compose a report on Climate Change policy

The draft Regulation, submitted by the European Commission in early June, specifies the limits for EU ETS operators on use of eligible credits from the Kyoto Protocol's project-based mechanisms (Clean Development Mechanism and Joint Implementation).
