### **COSME: €2.3 billion to foster the competitiveness of SMEs over the next seven years**

COSME aims to ease the access to credit problems that small businesses currently face. With a €2.3 billion-budget over the period 2014-2020 the Programme for the Competitiveness of Small and Medium-sized Enterprises (COSME) will for instance provide a guarantee facility for loans to small and medium sized enterprises (SMEs) of up to €150 000. From now until 2020, 330 000 EU firms are expected to benefit from this facility.

COSME will assist businesses and citizens in the following ways: 1) entrepreneurs will benefit from easier access to markets in the EU and beyond, 2) citizens who wish to become self-employed but currently face difficulties in setting up or developing their own business will receive tailored services and assistance, and 3) Member States' authorities will be better assisted in their efforts to elaborate and implement effective SME related policy reform.

### ERC joins the arXiv initiative

The European Research Council (ERC) informed that it has joined the international initiative of more than 170 institutions that financially supports arXiv, one of the major scientific repositories for electronic preprints in the fields of physics and mathematics. By joining the arXiv initiative the ERC expresses its support for the open access movement which stands for free access of scientific research papers for scientists and the public.

The ERC is the 1<sup>st</sup> EU research funding organization that has joined the international partnership supporting arXiv. Managed by Cornell University, New York (USA), arXiv offers scientists the possibilities to share their research papers online in form of preprint before publishing them, to archive their final accepted version or their published articles.

### European raw materials policy: Call for commitments of the EIP Raw Materials

The „European Innovation Partnership on Raw Materials“ has published its „Strategic Implementation Plan“ (SIP) on measures to ensure a sustainable supply of raw materials in Europe. In the focus of the EIP are non-energy and non-agricultural raw materials which also play a central role in the Societal Challenge 5 „Climate action, environment, resource efficiency and raw materials“ in Horizon 2020. The SIP includes actions like research and development, exchange of best practices, revision of selected legislations, licensing, standardisation and policy dialogues.

The European Directorate-General for Enterprise and Industry has launched an open call for „commitments“ focused on actors in the private, public and non-governmental sectors including academia. The submitted “commitments” have to be aligned with one or several “action areas”, which are described in detail in part II of the SIP. A conference on December 5 in Brussels will provide the opportunity to present the commitments and find additional partners.

### Horizon 2020 - the European Framework Programme for research and innovation - Questions & Answers

Horizon 2020 is the European Framework Programme for research and innovation. It is subsequent to FP7 and covers the period 2014-2020. Horizon 2020 supports research and innovation projects and programmes in ground breaking basic research, strategic and applied research, demonstration projects and close-to-market activities. Horizon 2020 is the financial instrument implementing the [Innovation-Union](#), a [Europe-2020](#) flagship initiative aimed at securing Europe's global competitiveness. In principle Horizon 2020 combines all research and innovation funding previously provided through the Framework Programmes for Research and Technological Development, the innovation related activities of the Competitiveness and Innovation Framework Programme (CIP) and the European Institute of Innovation and Technology (EIT). The total budget of Horizon 2020 will be 70.2 billion EUR for the period 2014-2020.

## Horizon 2020 and its budget

The European Parliament agreed the EU's budget for 2014-2020, as well as the final seal on the Horizon 2020 legislative deal. The overall EU budget for 2014 – 2020 has been voted through, securing a budget of €79 billion for Horizon 2020 and meaning the first calls can be launched as promised on December 11.

## A guide to ICT-related activities in WP2014-15

As a generic technology, ICT is present in many of the H2020 areas. The guide is designed to help potential proposers find ICT-related topics across the different parts of H2020. In WP 2014-15, ICT-related topics are covered as follows:

- Advanced research to uncover radically new technological possibilities & ICT contributions to research & innovation are addressed in the ‘Excellent science’ part of the work programme, respectively under ‘Future & Emerging Technologies’ and ‘European research infrastructures’ (‘eInfrastructures’);
- Research and innovation activities on generic technologies either driven by industrial roadmaps or through a bottom up approach are addressed in the ‘Leadership in enabling and industrial technologies’ (LEIT) part of the work programme, under ‘Information and communication technologies’;
- Multi-disciplinary application-driven research and innovation leveraging ICT to tackle societal challenges are addressed in the different ‘Societal challenges’.

## H2020. Work Programme 2014-2015 for ICT published

Electronics, microsystems and embedded systems underpin innovation and value creation across the economy. The objective is to reinforce EU's stronghold positions in these areas, to capture opportunities arising in new growth markets driven by advances in relevant technologies. Topics under this area contribute also to the implementation of parts of the Strategic Research Agendas of Artemis-IA ([www.artemis-ia.eu](http://www.artemis-ia.eu)) and EPoSS ([www.smart-systems-integration.org](http://www.smart-systems-integration.org)).

The first specific challenge addressed it to reinforce and expand Europe's leading industrial position in embedded systems and cyber-physical systems. The other two are driven by the vision that the heterogeneous integration of micro / nanotechnologies and materials into smart microsystems will deliver affordable high performance functionalities for a broad spectrum of use. Research and innovation in the various topics will also contribute to the implementation of the Strategic Research Agenda of the Public Private Partnership on Energy Efficient Buildings.

### Five Strategic Rules on Getting Maximum Effect from Minimum Means

We cannot be successful if we fail to understand the critical relationship between safety and power. Most people confuse the power the size of an effort. Large efforts seem more powerful even when they entail taking greater risks. This gets the formula for power exactly backwards. Properly understood, small moves are not only safer but more powerful.

We cannot confuse a small, concentrated action with a weak, half-hearted one. The problem is that many of us do not know how to concentrate our actions to create power and minimize risk simultaneously.

Considering the development of crowdfunding, the diversity of regulatory, supervisory, fiscal, social frameworks for it across the EU, we need a single EU framework to support those who develop crowdfunding platforms, to reduce the risks to those who make use of such platforms to finance projects"

The Scoreboard is based on a sample of 2,000 companies, the world's top investors in Research & Development representing more than 90% of the total expenditure on R&D by businesses worldwide. Leading world R&D investors have continued to increase their R&D investments by 6.2% in 2012, a figure above their net sales growth (4.2%).

The 527 EU companies increased R&D investment and net sales by the significant figures of 6.3 % and 4.3 % respectively. The 658 US companies reported a higher increase in R&D (8.2 %) but net sales grew only by 2.9 %, compared with a strong increase in 2011.
