A system of quality control of milk in Croatia and the Central laboratory for quality control of milk (CLMC) was established in 2002 as part of Croatian livestock centre within which is opened the Quality Assurance Department of Livestock Products. The central laboratory is accredited in accordance with HRN EN ISO / IEC 17025 in 2004.

Shortly after the establishment of the Laboratory (CLMC) Operating unit for controlling and evaluating half carcasses of domestic animals at slaughter houses (CESH) was officially established and began with labour. Work unit (CESH) is accredited as an inspection body in accordance with HRN EN ISO/IEC 17020 in 2008.

Within the Dapartment of quality control of livestock products there are also Department for animal feed control and Department for quality control of honey. Both accredited according to HRN EN ISO/IEC 17025.

By transforming the name of Croatian Livestock Centre in Croatian agricultural agency in 2009 there have been some changes within all departments, including the Quality Assurance Department of Livestock Products which got wider significance and transformed into the Department of quality control of agricultural products (DCAP).

Part of the Department is also laboratory for DNA analysis in animal husbandry. Department employs 60 staff of which 15 highly educated (including D.Sc.), while other employees have the secondary school qualifications.
