Five Western Balkan countries (Albania, Bosnia and Herzegovina, the former Yugoslav Republic of Macedonia, Montenegro and Serbia) and the Republic of Moldova secured full access to the EU's new 7 year research & innovation programme "Horizon 2020" by signing the association agreement in Brussels.

The association agreements, which will apply retroactively as from 1 January 2014, will allow research & innovation entities from this countries to take advantage of all the funding opportunities offered under Horizon 2020 right from the start.

16,000 applications to first round of Horizon 2020 calls

Some 16,000 applications have been received by the EC in the first calls of Horizon 2020, according to Robert-Jan Smits, director general of DG Research & Innovation. Speaking at the EuroScience Open Forum (ESOF) 2014, in Copenhagen, Denmark, he said that the Commission was "over-subscribed by a factor of nine. One reason for the heavy subscription to Horizon 2020's first set of calls could be the decreasing public investment in R&D in countries such as Italy and Spain.
